



## **OWNER-OPERATORS** CALIFORNIA SUPREME COURT DECSION THREATENS YOUR RIGHT TO EXIST

A recent California Supreme Court decision has established what is termed an A-B-C test for proper employment classification within the state. In order for you to be classified as an independent contractor (owner-operator/sub-hauler), three tests MUST be passed. Fail one and you are classified as an employee. The second part of the test is virtually impossible for most to pass. The three tests are:

- A. That the worker is free from the control and direction of the hiring entity in connection with the performance of the work, both under the contract for the performance of the work and in fact; and
- B. That the worker performs work that is outside (different then) the usual course of the hiring entity's business; and
- C. That the worker is customarily engaged in an independently established trade, occupation, or business of the same nature as the work performed.

Most owner-operators (regardless of name such as sub-haulers, pullers, full-unit etc.) who contract their work through brokers/motor carriers cannot pass the "B" part of the test because both are in the business of trucking and would therefore be under state labor law classified as an employee of the broker/motor carrier and will lose their independence!

# WHAT CAN YOU DO?

The Western States Trucking Association (WSTA) has filed a federal lawsuit to protect your ability to continue to operate as an independent businessperson. Filing the lawsuit is just the start of the litigation effort.

The association is also aggressively engaged in trying to work toward a legislative fix that would nullify the Supreme Court decision at least temporarily through the "I'm Independent Coalition".

\*F4A stands for the Federal Aviation Administration Authorization Act. In 1994, Congress laid down an important principle for the commercial trucking industry: that the federal government – not individual states – should determine the rules for interstate and intrastate trucking. The law prohibits states from enacting or enforcing policies "related to a price, route, or service of any motor carrier." The Supreme Court has repeatedly recognized that this language is expansive and applies to anything with a significant effect – direct or indirect – on motor carrier prices, routes or services.
